Hammonds reserves the right to sell directly to the US Military or its appointees for equipment and additives directly to the Iraqi Government and MOD for projects other than no. 385. This appointment in no way creates any agency for any current Hammonds contracts, understandings, negotiations or other projects in place or proposed with the US MILITARY for equipment that may end up in Iraq.

Territory:

The term "Territory" as used in this Agreement is defined to mean only the accounts noted in the country of IRAQ.

Laws:

You agree to act in accordance with all laws affecting the export of products from the United States as may be applicable, to conduct yourself in an ethical and professionally manner bring no disrespect upon the
